The January Monthly Petroleum Technology Forum meets Tuesday, January 10, 2006 at the Long Beach Petroleum Club. Mark Shemaria of Tidelands Oil Production Company will be joined by Ivan Tether to present a discussion titled “Air issues for E&P Operators in the South Coast Basin.” An abstract and bios are provided below.

Abstract:

Oil producers in the Los Angeles Basin are faced with many environmental issues impacting their operations. In these times of favorable pricing, improved producing operations often involve surface facilities revisions often resulting in air quality environmental issues.

Biographies:

Mark Shemaria is the Manager of Environmental, Health, Safety and Community Affairs at Tidelands Oil Production Company, the primary onshore contract operator of the Wilmington Oil Field for the City of Long Beach. He is also President of Tidelands’ subsidiary Lomita Gasoline Company, Inc. Mark’s professional career spans 24 years in oil and gas production at Thums Long Beach Company and Tidelands Oil Production Company. Mark received a B.Sc. in Engineering and Industrial Technology 1981 and a M.B.A. in 1990, from California State University, Long Beach. In 1988 he received a Certificate, in Hazardous Material Management from the University of California, Irvine. Mark is actively involved in SPE and has Chaired many forums on Pollution Prevention and Environmental Technology. Mark was awarded SPE’s Environmental, Health and Safety Award in 2002. He is a Registered California Environmental Assessor and a Licensed California State Contractor in General Engineering with Hazardous Substance Certification.

Ivan Thether is LA Environmental chair, a past director of the California Independent Petroleum Association, and a former trust and environmental section chair of the LA County Bar Association. He graduated from Union College and Georgetown University Law Center, and is admitted to practice in California state courts, before the Central, Eastern and Northern Districts of the Federal District Courts in California and in the District of Columbia. In mid-2004, Ivan opened his own law practice, Tether Law, continuing his 30 year legal career advising and advocating for clients on environmental issues, most notably before air quality management districts. He has represented clients before air quality hearing boards for over 125 variance petitions, in the South Coast, San Joaquin Valley, Ventura and Santa Barbara.

SPE Awards Criteria and Nomination Procedures

The SPE honors its members with awards recognizing their technical and service achievements. Although any SPE member in good standing may make award nominations, the LASPE Board wishes to encourage recognition of its outstanding members with review and support of their nominations.

Nominations are due at SPE headquarters by February 15, 2006. The LASPE Board of Directors encourages you to review the following summary of SPE Awards and forward your nominations to Pat Shuler by email at pjshuler@peer.caltech.edu.

The Anthony F. Lucas Gold Medal recognizes new technology and concepts in the practice of finding or producing petroleum.

The John Franklin Carll Award recognizes contributions of technical application and professionalism in petroleum development and recovery.

The Lester C. Uren Award recognizes distinguished achievement in the technology of petroleum engineering by a member who made the contribution before age 45.

SPE also provides Technical Awards for outstanding achievements in or contributions to the advancement of the following engineering disciplines. The recipient must be a member of SPE in good standing.

- Drilling and Completions Award
- Projects, Facilities and Construction Award
- Formation Evaluation Award
- Health, Safety and Environment Award
- Management and Information Award
- Production and Operations Award
- Reservoir Description and Dynamics Award

The SPE Public Service Award is presented for humanitarian efforts and commitment to public service through dedicated service and leadership to a candidate with at least five consecutive years membership in good standing.

The DeGolyer Distinguished Service Medal recognizes distinguished and outstanding service to SPE, the professions of engineering and/or geology, and to the petroleum industry to a candidate who is a member of SPE with at least 15 years professional experience in the petroleum industry.

The SPE Distinguished Service Award recognizes contributions to the Society that exhibit such exceptional devotion of time, effort, thought, and action as to set them apart from other contributions.

International SPE Awards – Continued

The SPE Young Member Outstanding Service Award recognizes contributions to and leadership in public and community matters, the Society, the petroleum engineering profession, and/or the petroleum industry.

Honorary Membership is conferred on individuals for outstanding service to SPE and/or in recognition of distinguished scientific or engineering achievement in fields encompassed in the Society's technical scope. Honorary Membership is the highest honor the Society bestows on an individual and it is limited to 0.1% of the Society's total membership.

SPE Distinguished Member classification recognizes those members of the Society who achieve distinction deemed worthy of special recognition. It is a means of acknowledging members who have attained eminence in the petroleum industry or the academic community, and/or who have made unusually significant contributions to SPE.

Any member may nominate a worthy candidate. The detailed nomination procedure is available at www.spe.org and is outlined below:

Awards are presented at the SPE Annual Technical Conference and Exhibition. Nominees may still eligible in subsequent years.

1. Identify the appropriate award from the list of honors and awards
2. Write a description of why the candidate should be recognized.
3. Provide a biographical profile of the nominee including a current resume.
4. List any worldwide, national, local, company/academic, or public service contributions not covered in the biographical profile.
5. Complete the nomination form, available online.
6. Submit all information above by February 15.

When the nomination is received, SPE will attach to the nomination a list of the candidate's SPE service record – offices and positions held at both Society and section levels. Forms and further information can be found at awards@spe.org.

The Western North America Distinguished Corporate Support Award recognizes outstanding support by an organization and distinguished service to SPE members in the region through excellence in leadership and through the commitment of time, energy and professional resources.

The Western North America Service Award acknowledges exceptional contributions to SPE at the section or regional level and recognizes devotion of time and effort to the programs and development of the member's section and region. Since 1984, 21 members of the LA Basin Section have received this award and four members have received it in 2004 and 2005.

REGIONAL AWARD RULES AND ELIGIBILITY

SPE Regional Technical Awards

Rules

- A. The SPE Regional Technical Awards acknowledge exceptional contributions to the Society of Petroleum Engineers at the section or regional level and recognize singular devotion of time and effort to the programs and development of technical expertise in one of the following six disciplines: Drilling and Completions; Reservoir Description and Dynamics; Production and Operations; Facilities and Construction; Health, Safety, Security, Environment and Social Responsibility; and Management and Information.
- B. Each award shall be presented upon recommendation of a Regional Technical Awards Committee appointed by the Regional Director based on nominations received from section leaders within the region. The nominations must also receive the approval of the appropriate SPE Technical Director for that discipline. The award shall consist of a plaque, which shall include the name of the recipient, the year of the award presentation, and the citation accompanying the award specific to their contribution to that technical discipline within the region.
- C. The importance of each award shall be maintained by issuance only to individuals whose contributions to the technology stand out sharply. Further, the Regional Director has the responsibility to nominate only individuals whose contribution advance the discipline merit recognition. No more than one award in each discipline may be made annually in each region.
- D. The award shall be presented at an SPE section, region, or topical meeting as determined by the Regional Director.

Recipients of the Regional Technical Awards will also automatically be included as candidates for the Society-wide technical awards the following year.

Eligibility

The conditions of eligibility for the awards are as follows:

- A. Recipients of the any of the following SPE-wide awards shall not be eligible for the Regional Technical Awards: SPE Formation Evaluation Award; SPE Drilling and Completions Award; SPE Reservoir Description and Dynamics Award; SPE Production and Operations Award; SPE Facilities and Construction Award; SPE Health, Safety, Security, Environment and Social Responsibility; or the SPE Management and Information Award.
- B. Any member of the Society of Petroleum Engineers in good standing and a current or past member of the region presenting the award shall be eligible to receive the award except if they have resided outside of the region for more than one year and as noted above.
- C. Recipients of the award must be willing to personally receive the award at the site selected by the Regional Director; however, the death of a person subsequent to his selection as an award recipient by the Regional Director or Award Committee shall not render that person ineligible to receive the award, and presentation of the award shall be made posthumously as indicated by the SPE Regional Director.
- D. No other limitations shall be placed on a candidate's eligibility for the award.

SPE Regional Outstanding Young Member Award

Rules

- A. The Regional Outstanding Young Member Award recognizes contributions and leadership to the public and the community, with respect to local custom, as well as to the Society of Petroleum Engineers, the profession of petroleum engineering, or the petroleum industry within the region. It is intended to encourage interests among the young members of the Society that are broader than the profession, and no award shall be presented solely on the basis of a candidate's contribution to the Society, the profession of petroleum engineering, or the petroleum industry.
- B. The award shall be presented upon recommendation of a regional Outstanding Young Member Award Committee appointed by the Regional Director based on nominations received from section leaders within the region. The award shall be a plaque engraved with the name of the recipient, the year in which the award is presented, and a citation stating the reason for giving the award.
- C. The importance of this award shall be maintained by issuance only to individuals whose contributions stand out sharply given their age and level of participation in the Society and/or community. Each region may make only one Regional Outstanding Young Member Award each year.
- D. The award shall be presented at an SPE section, region, or topical meeting as determined by the Regional Director.

Eligibility

- A. Any member of the Society of Petroleum Engineers in good standing and 35 years of age or under during the year of presentation of the award shall be eligible to receive the award. The candidate cannot be a previous winner of the SPE Young Member Outstanding Service Award, but by way of this nomination would be automatically under consideration for the Society award the following year if he/she still meets the age and award criteria.
- B. A candidate must be living and able to receive the award at the time and place agreed upon. However, the death of a candidate subsequent to 1 May does not render them ineligible during that year, and if duly selected for the award, the presentation shall be made posthumously in accordance with special procedures to be prescribed by the SPE Regional Director.
- C. Anyone residing outside of the region for more than one year is not eligible for this award.
- D. No other limitations shall be placed on a candidate's eligibility for the award.

SPE Regional Distinguished Corporate Support Award

Rules

- A. The SPE Regional Distinguished Corporate Support Award recognizes outstanding support by an organization and distinguished service to SPE members in the region through excellence in leadership and through the commitment of time, energy and professional resources. It is intended to recognize companies that help make contributions to the support of SPE membership, programs, and events and not solely through financial assistance to the Society or the petroleum industry.
- B. The award shall be presented upon recommendation of a regional Corporate Award Committee appointed by the Regional Director based on nominations received from section leaders within the region. The award shall be a plaque engraved with the name of the recipient, the year in which the award is presented, and a citation stating the reason for giving the award.
- C. The award shall be presented to a designated company representative at an SPE section, region, or topical meeting as determined by the Regional Director.

Nominations and Elections

- A. Nominations may be submitted to the Regional Director or the designated region's award committee by any member in the region. Nominations must be received by the Regional Director before 15 February. Each nomination must include a full and complete statement of the reasons for proposing the candidate, and sufficient supporting documentation to enable the Regional Director or the award committee to judge the candidate's worthiness to receive the award.
- B. The procedure to be followed by the Regional Director or the designated regional award committee in the selection of an award recipient for the Regional Technical Awards, the Regional Outstanding Young Member Award, and the Regional Distinguished Corporate Support Award will follow the same timeline and process as submission of the Regional Service Awards.

SPE Regional Service Award

Rules

1. The SPE Regional Service Award acknowledges exceptional contributions to the Society of Petroleum Engineers at the section or regional level and recognizes singular devotion of time and effort to the programs and development of the member's section and region that set it apart from the services rendered each year by many members of the Society.
2. The Award shall be presented upon recommendation of the Award Committee and shall consist of a certificate, which shall include the name of the recipient, the year of the Award presentation, and the citation accompanying the Award.
3. The importance of this Award shall be maintained by issuance only to those individuals whose contributions stand out sharply; however, this does not preclude the Award Committees' selecting up to three individuals each, annually, to receive the Award.

4. The Award shall be presented at a section, regional, or topical meeting as determined by the Award Committee. The host region for the SPE Annual Technical Conference and Exhibition (ATCE) may, also, at its discretion, present its awards at the Section Officers Workshop or other appropriate function during the ATCE.

Eligibility

5. The conditions of eligibility for the Award are as follows:
 - A. Officers and directors of the Society shall be ineligible to receive the Award until one year after their term of office has expired.
 - B. Recipients of the DeGolyer Distinguished Service Medal or the SPE Distinguished Service Award shall not be eligible for the Regional Service Award.
 - C. Any Member or Associate Member of the Society of Petroleum Engineers, Inc., in good standing and a current or past member of the region presenting the Award, except as noted in "5.A. and B." above, shall be eligible to receive the Award.
 - D. Recipients of the Award must be willing to personally receive the Award at the site selected by the Award Committee; however, the death of a person subsequent to his selection as an Award recipient by the Award Committee shall not render that person ineligible to receive the Award, and presentation of the Award shall be made posthumously as indicated by the SPE Board of Directors.
 - E. No other limitations shall be placed on a candidate's eligibility for the Award.

Committee of Award

6. The Award Committee shall consist of the chairperson of each section within the region presenting the Award or his designee. The SPE regional director representing the region presenting the Award shall serve as committee chairperson and shall be a voting member of the committee.
7. The Award Committee shall have the power to rule on matters not specifically covered by these rules, and all issues, except the selection of an Award recipient, shall be decided by a majority vote of the committee.

Nominations and Election

8. Nominations may be submitted to the Award Committee by any member of the region presenting the Award. Such nominations must be in the hands of the chairperson before February 15* and each must be accompanied by a memorandum giving a full and complete statement of the reasons for proposing the candidate, with a record of his contributions to his section or region in sufficient detail to enable the committee to judge the candidate's worthiness to receive the Award.
9. The procedure to be followed by the Award Committee in the selection of an Award recipient shall be as follows:
 - A. Prior to February 15, the chairperson of the Award Committee shall provide each member of the committee with the names of those living candidates then on the active list for the Award.
 - B. If possible, the committee shall meet to conduct the election procedures; however, in the event a meeting of the committee is not possible, after February 15* but before March 1*, the chairperson

of the committee shall provide each committee member with a ballot, listing all candidates eligible for the Award as determined under Rule 5 above. The ballot shall also include the name of the person submitting each nomination and a copy of the memorandum supporting the nomination. Each committee member will return the ballot to the committee chairperson no later than April 15*, voting for up to three of the candidates. There is no provision for "conditional" or "alternate" votes, and the committee chairperson shall ignore all such comments in tabulating results of ballots. Candidates receiving the votes of a majority of the committee shall be considered formally selected, unless more than three candidates receive a majority.

- C. In the event no candidate receives a majority on the first ballot, the chairperson shall submit to each committee member a second ballot listing candidates who received one or more votes. If no candidate receives a majority on the second ballot, a third ballot will be submitted, listing all candidates receiving one or more votes on the second ballot. If no candidate receives a majority on the third ballot, a fourth ballot will be submitted listing all the candidates receiving one or more votes on the third ballot. If no candidate receives a majority on the fourth ballot, no Award will be presented for that year.
 - D. If a majority is received by more than three candidates on any ballot, another ballot listing all of the candidates who received a majority will be issued with each committee member voting for up to two of the candidates on this ballot. Those receiving a majority shall be considered formally selected.
10. The unsuccessful candidates shall constitute an active list but, after being considered by three Committees of Award, a candidate will be dropped from the list. This, however, does not make him ineligible for re-nomination. If a candidate is nominated while on the current active list, his eligibility shall not be extended beyond the three years granted by the original nomination, and the committee chairperson shall advise such nominator that his nominee is currently being considered by the Award Committee, advising him when the candidate's term on the active list will expire and inviting him to renominate his candidate at that time. Any memoranda received in support of candidates already on the current active list may, however, be considered by the current Award Committee.
11. If a candidate is selected, the chairperson of the Award Committee shall prepare a citation (not exceeding 50 words) to accompany the Award and shall submit the citation to the Award Committee for approval.
12. Within two weeks after the completion of his term as an SPE director, the regional director shall deliver the records of the candidates to the person beginning his term as director of the region. The records shall, at all times, be accessible to the member of the committee and to members of the SPE Board of Directors.
